- 6. All information presented in the video must be cited, giving credit to the source. Plagiarism of any kind will result in disqualification. You DO NOT need to include your citations in your video. IF CHOSEN AS A FINALIST, you must submit a list of your sources, properly cited.
- Each video must have one Lead Producer to serve as the main point of contact. Recognition and prizes will be given to the lead producer and all those listed as coproducers on the entry form.
